



Conditions for Mechanics/Designated person on the <u>Dummy grid/Weighbridge area ONLY</u> – <u>PLEASE READ</u> <u>Date:.....</u>

I indemnify that: I am at least 16 years or over in age & will abide by the following:

- Wear an orange high-visibility vest at all times.
- Only one designated person is allowed in the pit area or the dummy grid with each driver at any time and they must wear a hi-vis vest and a colour coded wrist band; wrist bands issued at briefing.
- When pushing off from the dummy grid, if the kart fails to start before the **acceleration point (SAFE LINE)** i.e. "start/finish line", then both the driver and the kart must be clear of the track and make their way to a safe area. i.e. Pit One within the track boundary.
- Supporters must not coach or intimidate drivers from trackside.
- RLK LTD marshalling staff <u>are not allowed</u> to act as pushers but they are allowed to move a broken-down kart to
 a place of safety. Only one attempt can be made to start a Honda Cadet kart using the pull cord. Any driver with
 a broken-down stationary kart on the live circuit will be instructed to stand in a place of safety making sure all
 protective wear is kept on until the racing has finished & they have returned to the paddock and are outside the
 circuit boundary fence.
- Only <u>one</u> designated Mechanic is allowed with a driver that has submitted a race entry.
- You must abide by the Officials commands at all times.
- Stationary karts MUST be removed from the circuit on to the infield or outfield immediately after each race
 under the strict guidance of the circuit Race Marshals/Officials. maybe held in a safe position/area at the
 discretion of RLK Race Marshals/Officials.
- Please use the Trolley Park located in front of the garages adjacent to the Dummy grid.
- NO smoking (including the use of a vape) anywhere inside the circuit's perimeter gates /fence.
- Parents/Guardians are responsible for any juveniles in their care at all times.
- Be responsible for the safe keeping of any equipment & belongings whilst on the premises of Red Lodge Karting Ltd.
- By signing the indemnity form you are ensuring that you are in good health; in particular are not suffering from any illness or disability which shall or may damage or impair your ability to assist the driver & their kart.
- Ensure you have attended a Dummy grid Safety briefing.
- You have not consumed or intended to consume any alcohol or drugs before or during your time here at Red Lodge Karting Ltd.
- COVID-19 wearing a face mask & practicing social distancing from other individuals not in your bubble group must be adhered to at all times whilst on the site of Red Lodge Karting Ltd.

ANY PERSONS NOT RESPONDING TO THE OFFICIALS INSTRUCTIONS OR FOUND TO BE IN BREACH OF ANY OF RED LODGE KARTING'S LTD RULES, WILL BE REMOVED FROM THESE AREAS.
