

RACE COMPETITOR INDEMNITY: 2023**PLEASE READ**

Every Driver Entrant before taking part in any competition round must sign a driver competitor sheet on the race day and an undertaking as follows:

- I declare that I have been given the opportunity to read the Club 2000 Rules and Regulations for this event and agree to be bound by them. I declare that I am physically and mentally fit, do not have any existing medical conditions or injuries which would put me at risk in any karting activities at Red Lodge Karting Ltd (RLK Ltd), and I am competent to do so. I acknowledge that I understand the nature and type of competition, the potential risk inherent with motor sport and agree to accept that risk.
- I understand that motorsport can be dangerous and accidents causing death, injury, disability and property damage can and do happen.
- I confirm I will not eat nor chew gum whilst driving a kart.
- I understand that these risks may give rise to my suffering personal injury or other loss, and I acknowledge and accept these risks. In consideration of the acceptance of this entry, I agree that Club 2000, the organisers, the track owners, the promoters and their respective officers, trackside staff and medical personnel shall not have any liability for loss or damage which may be sustained or incurred by me because of participation in the event, including but not limited to, damage to property, economic loss, consequential loss or financial loss howsoever caused. Nothing in this clause is intended to or shall be deemed to exclude or limit liability for death or personal injury.
- To the fullest extent permitted by law I agree to indemnify and hold harmless each of the parties in respect of any loss or damage whatsoever and howsoever arising from my participation in this event.
- I declare that to the best of my belief the driver(s) possess(es) the standard of competence necessary for an event of the type to which this entry relates, the kart entered is suitable and circuit-worthy for the event having regard to the course and the speeds which will be reached.
- I have read and fully understood the procedure for the Control of Drugs and Alcohol as contained in the Competitors and Officials Yearbook Regulations H39, D35.1, G15.1.4. I have also fully familiarised myself with the information on the website referred to (www.ukad.org.uk). If I am counter-signing as the parent or guardian of a minor then, in addition to the deemed consent to the testing of that minor (UKAD Code Art 5.6.2), I hereby confirm that I give such consent for the minor concerned to be so tested.
- I have provided RLK Ltd with any requested additional information ie. Bambino/Cadet drivers are REQUIRED to submit an original birth certificate for retention on file.
- A FULL MSA licence, if held, must be shown by all drivers at their first race meeting at both signing on and at scrutineering. Failure to do so will result in the driver being classed as a novice for that meeting.
- I confirm I have signed the Crash Helmet Disclaimer sheet situated in the scrutineering bay.
- I confirm and will ensure that I am wearing the required race safety wear set by RLK and it is properly fastened, ensuring long hair is tied and tucked into my race suit, and that I will ensure this is shown to a scrutineer to approve during scrutineering. I will not wear a scarf, dangling jewellery, fingerless gloves, a hood attached to a top, bandana, opened back high heeled shoes/boots/sandals and not carrying an iPod whilst sitting/driving in a kart.
- Indemnify RLK Ltd in respect of all liabilities of whatever kind incurred by my recklessness, negligence or failure to carry out orders, instructions and commands of the Clerk of the Course and Race Marshals whilst on RLK Ltd premises.
- Be responsible for the safekeeping of my kart, equipment and belongings whilst on the premises of RLK Ltd.
- Leave the premises of RLK Ltd for whatever reason when requested by either the Clerk of the Course or a Manager from RLK Ltd.
- Adhere to the Covid-19 RULES IN PLACE
- **By paying my fee and SIGNING THE DRIVER INDEMNITY FORM, I accept this disclaimer and I agree to attend a safety briefing and fully understand the risks involved.**
- **Cadet & Junior Drivers under 16 years require their parent/guardian's signature as consent.**
- **I am AT LEAST the age of 16 years old – own signature required**
