

# Club2000 Driver Indemnity



**I, the undersigned, hereby declare that I have read and understood the conditions hereunder and that I agree to abide by these terms:**

**1.** I declare that I have been given the opportunity to read the Club2000 rules and regulations (outlined at [www.redlodgekarting.com/club2000-regulations](http://www.redlodgekarting.com/club2000-regulations)) and agree to be bound by them. I understand that failure to comply with these rules and regulations will lead to consequences such as penalties, or even exclusion/removal from the event with no refund.

**2.** I declare that I am physically and mentally fit, do not have any existing medical conditions or injuries which would put me at risk this event, and I am competent to do so. I acknowledge that I understand the nature and type of competition, the potential risk inherent with motorsport and agree to accept that risk.

**3.** I understand that motorsport can be dangerous and accidents causing death, injury, disability or property damage can and may occur.

**4.** I understand the use of foul language/threatening behaviour will not be tolerated and I will leave the premises of Red Lodge Karting Ltd for whatever reason when requested by the management. I understand I am responsible for the behaviour of my supporters, family and friends, and that the health & safety rules equally apply to them. Red Lodge Karting Ltd reserves the right to withdraw any participant from this activity and/or cancel an activity or event should any participant's behaviour cause concern for the safety of others or staff.

**5.** I understand that these risks may give rise to my suffering personal injury or other loss, and I acknowledge and accept these risks. In consideration of the acceptance of this entry, I agree that Club2000, the organisers, the track owners, the promoters and their respective officers, trackside staff and medical personnel shall not have any liability for loss or damage which may be sustained or incurred by me because of participation in the event, including but not limited to; damage to property, economic loss, consequential loss or financial loss howsoever caused. Nothing in this clause is intended to or shall be deemed to exclude or limit liability for death or personal injury.

**6.** To the fullest extent permitted by law I agree to indemnify and hold harmless each of the parties in respect of any loss or damage whatsoever and howsoever arising from my participation in this event.

**7.** I declare that, to the best of my belief, I possess the standard of competence necessary for this event and that the kart entered is suitable/circuit-worthy with regards to the nature of the circuit and speeds which will be sustained in this event.

**8.** I confirm that I will not attempt to participate in this activity while under the influence of alcohol, drugs or any substances that may affect my ability to drive a car or operate heavy machinery. I also understand that being under the influence of drugs or substances that will enhance my performance in the event are not permitted.

**9.** I agree to report any accidents, whether personal or suffered to another member of my party (spectators included), to a Red Lodge Karting Ltd staff member and advise if hospital treatment is required. Red Lodge Karting Ltd is required to report accidents to HSE if a person(s) is taken directly to hospital with a major injury. Red Lodge Karting Ltd will hold any/all equipment of the person(s) involved until they are discharged. Red Lodge Karting Ltd will immediately check for & log any damage incurred. Any required repair work will be undertaken and recorded before any affected equipment is used again.

**10.** I will ensure that no spectators in my party will enter the circuit boundary (outlined by fences or gates). Only my designated accompanying mechanic (who must sign to confirm this) is permitted within the weighbridge or

dummy grid areas (outlined by signage). I understand that, in the event that I need to retrieve my kart from the circuit, both me and my designated mechanic will be under the supervision of Red Lodge Karting Ltd staff and this will only be permitted when the track is clear of all vehicles or other dangers.

**11.** I will ensure that, when me (when not wearing all safety equipment) or my designated mechanic are within the circuit boundary (outlined by fences or gates) that a high-visibility vest will be worn at all times. I understand that failure to do so will result in the removal of both me or my designated mechanic from the circuit boundary.

**12.** I understand that no smoking or vaping is allowed inside the circuit's boundary and that I am responsible for the safe keeping of my goods, belongings, equipment and kart whilst on the premises of Red Lodge Karting Ltd.

**13.** I, the undersigned, will not hold Red Lodge Karting Ltd or any member of Red Lodge Karting Ltd staff responsible should anything happen to me or any members of my party. I hereby waive any rights against Red Lodge Karting Ltd.

**14.** I have provided Red Lodge Karting Ltd with any requested additional information i.e. a birth certificate may be required, at the discretion of Red Lodge Karting Ltd, to be copied and kept on file as per our health and safety policy.

**15.** I confirm and will ensure that I am correctly wearing the required racewear as per the Club2000 House Regulations, HR.5 ([www.redlodgekarting.com/club2000-regulations](http://www.redlodgekarting.com/club2000-regulations)). I will also ensure that this racewear will be shown to a scrutineer to approve during scrutineering.

**16.** I will not wear a scarf, any dangling jewellery, a hood attached to my clothes or a bandana under/over my safety equipment. In addition to this, I will not eat, chew gum or have anything loose in my mouth while driving my kart.

**17.** I confirm that my kart is fit for purpose, maintained to a good standard and complies with the relevant rules and regulations for my class of kart outlined at [www.redlodgekarting.com/club2000-regulations](http://www.redlodgekarting.com/club2000-regulations). Alongside this, I understand that if upon scrutineering my kart is found to be unsuitable for the event, I will not be able to take part and no refund will be given.

**18.** I understand that photographs may be taken of me by a member of Red Lodge Karting Ltd or a third-party photographer whilst on site. These images may appear on (but not limited to) social media, our website, or marketing/service emails.

**19.** I indemnify Red Lodge Karting Ltd in respect of all liabilities of whatever kind incurred by my recklessness, negligence or failure to carry out orders, instructions and commands of any staff whilst on the Red Lodge Karting Ltd premises.

**20.** I confirm to leave the premises of Red Lodge Karting Ltd for whatever reason when requested by the appointed Race Director, Clerk of Course or circuit manager.

**21.** By paying my fee and signing this indemnity form, I accept this disclaimer, agree to attend and pay attention to the safety briefing and fully understand the risks involved.

**22.** I confirm that I am over the age of 16yrs old or are countersigning as a parent/guardian on behalf of a driver who is under the age of 16yrs old.

**23.** I confirm I have made myself aware of the fire safety procedures which are displayed around the building and stated as follows: In the event of the siren sounding, please make your way immediately to the fire assembly point in the middle of the front car park.
